## WARRANTY PROVISIONS

Your foundation repair contractor offers you warranty protection as a value-added service designed to provide you with additional peace-of-mind and confidence.

For a period of ten (10) years beginning on the date you sign off on your foundation repair, your contractor warrants that there will be no downward movement of any pier they installed as part of their foundation repair process.

If any pier experiences movement during the ten-year warranty term, warranty action will be taken. The warranty limit is \$10,000. Please reference the Warranty Coverage Booklet for terms, conditions, and exclusions.

It is important to note that your warranty is completely transferable during the warranty term. This provides you with an additional marketing tool in the event you decide to sell your home and protects the buyer against future issues or liabilities.
